1. Consumer Laws

If you acquire the Product from an Authorised Reseller in European Union and the Consumer Law applies, including Great Britain, the Product comes with guarantees that cannot be excluded under the Consumer Law. You are entitled to a replacement or refund for a major failure and compensation for any other reasonably foreseeable loss or damage.
